Out of the thousands of bills which have been introduced so far we will have a better idea of which ones are still alive at that point in the meantime. Here is a summary of the ones I am following for ICCA. AIA also waiting to hear back from us to oppose the SB 1270- Registered Design Practitioner

HB 2568 – State Agency Building Code Notification - Rep. Tryon's bill that he introduced for us that requires state agencies to post changes to any administrative rule impacting building codes 30 days prior to being filed with SOS, passed the House Executive Committee this week 7-4. There was quite a lengthy debate with IDPH opposing and Rep. David Harris who sits on JCAR being concerned of it's impact on JCAR process if the agency "forgets" to post it. Regardless the bill passed and it headed to the House floor. I would like to get additional sponsors (especially DEMs) and make sure we get AIA, Homebuilders and IML more proactive in their support. Please contact your state representatives and urge a yes vote on HB 2568.

Amends the Elevator Safety Act. Provides that the Office of the State Fire Marshal (rather than the Elevator Safety Review Board) shall authorize the issuance of elevator contractor's licenses, elevator mechanic's licenses, inspector's licenses, and inspection company licenses. Further provides that the Board no longer has the power to establish fee schedules for inspections of conveyances. Requires that the Board prescribe an inspection form, which shall be the only inspection form used by a person, company, or home rule unit licensed to inspect conveyances under the Act. Provides that all applications for a contractor's or inspection company license shall contain a copy of the Certificate of Authority to transact business in the State from the Secretary of State for corporations registered in another state, a certificate of good standing for corporations registered in Illinois, and an assumed name certificate issued by the Illinois county in which the business is located for a sole proprietor or partnership. Requires that all injuries caused by a malfunctioning conveyance be reported to the Office of the State Fire Marshal within 2 business days.

Amends the School Safety Drill Act. With respect to the report produced after the annual review required to be conducted by a public school district, requires the report to report any renovation or addition to a school building or a change in the floor plan, any emergency and crisis response plan, or any evacuation plan of a school building and acknowledge that there has been submission of a change in floor plans, an emergency and crisis response plan, or an evacuation plan to the local fire department, the local law enforcement agency, or other emergency responders. Provides that, within 30 days after completion of any renovation or addition to a school building or a change in the floor plan, an emergency and crisis response plan, or an evacuation plan of a school building that modifies a previously approved emergency crisis response plan at least 60 days prior to the annual review meeting required to be conducted by a public school district, the school board or its designee shall contact the local fire department, the local law enforcement agency, and other emergency responders to set up a meeting to review any changes in procedures and protocols affected by building modifications as a result of renovations, additions, or changes in floor plans, an emergency and crisis response plan, or an evacuation plan. Effective immediately.

Amends the Illinois Building Commission Act. Provides that, at least 30 days prior to filing rules pertaining to the adoption or amendment of any statewide code pertaining to building construction, each State agency must provide notice to the Illinois Building Commission. Provides that the Commission must identify the proposed code, by the title and edition, or by the amendment, to the public on the Internet. Effective immediately.

Provides that the division regarding administrative adjudications is applicable to municipalities that are both home rule and non-home rule units (rather than to just home rule units). Repeals the Code Hearing Departments Division concerning code hearing departments in non-home rule units of local government 90 days after the effective date of this amendatory Act. Provides that 90 days after the effective date of this amendatory Act all code hearing departments formed under the repealed division shall conduct code enforcement, hearings, and all actions in accordance with the provisions of the Administrative Adjudications division. Further provides for other changes allowing code enforcement departments created under the Code Hearing Departments Division to operate pursuant to the Administrative Adjudications division. Effective immediately.

Synopsis As Introduced

Amends the Plumbing License Law. Provides that Illinois licensed professional engineers and licensed environmental practitioners who provide continuing education for licensed plumbers are not required to have oversight of their continuing education sponsorship or courses by any other licensed profession or Illinois licensed plumbers, have their programs reviewed by another licensed professional or Illinois licensed plumber, or have another licensed professional or Illinois licensed plumber attend or provide oversight of their continuing education courses or programs. Provides that Illinois licensed professional engineers and licensed environmental practitioners who provide continuing education for plumbers are not required to provide a licensed plumber of record when submitting sponsorship or continuing education course approval. The oversight and approval of the Department of Public Health's Plumbing Inspector shall be sufficient oversight for sponsor or course approval submitted by Illinois licensed professional engineers and licensed environmental practitioners. Provides that no additional requirements for the approval for the Illinois licensed professional engineers and licensed environmental practitioners as a sponsor or for approval of a continuing education course shall be mandated. Effective immediately.

Amends the Elevator Safety Act. Provides that the Office of the State Fire Marshal (rather than the Elevator Safety Review Board) shall authorize the issuance of elevator contractor's licenses, elevator mechanic's licenses, inspector's licenses, and inspection company licenses. Further provides that the Board no longer has the power to establish fee schedules for inspections of conveyances. Requires that the Board prescribe an inspection form, which shall be the only inspection form used by a person, company, or home rule unit licensed to inspect conveyances under the Act. Provides that all applications for a contractor's or inspection company license shall contain a copy of the Certificate of Authority to transact business in the State from the Secretary of State for corporations registered in another state, a certificate of good standing for corporations registered in Illinois, and an assumed name certificate issued by the Illinois county in which the business is located for a sole proprietor or partnership. Requires that all injuries caused by a malfunctioning conveyance be reported to the Office of the State Fire Marshal within 2 business days.

Senate Committee Amendment No. 1

Replaces everything after the enacting clause with the introduced bill with the following changes: removes provisions regarding a licensed inspector prescribing his or her own inspection procedures and regarding inspection company licensure.

Amends the Regulatory Sunset Act. Extends the repeal date of the Illinois Roofing Industry Licensing Act from January 1, 2016 to January 1, 2026. Amends the Illinois Roofing Industry Licensing Act. Makes changes in provisions concerning: definitions, application procedures,

inactive licenses, qualifying parties, fees, grounds for discipline, disciplinary procedures, surrender of licenses, suspension of licenses, the Roofing Advisory Board, and home rule. Authorizes the Department of Professional and Financial Regulation to compel physical or mental evaluations of licensees when necessary to ensure compliance with the Act. Adds provisions concerning confidentiality of investigative information and the issuance of citations. Makes other changes. Effective immediately.

Creates the Illinois Registered Design Practitioner Act. Provides for licensure of registered design practitioners by the Department of Financial and Professional Regulation. Provides for the registration of professional registered design firms not already registered under the Professional Service Corporation Act. Creates the Registered Design Practitioner Licensing Board and sets forth the powers and duties of the Board. Sets forth the powers and duties of the Department, exemptions from the Act, licensure qualifications, grounds for discipline, civil and criminal penalties, and administrative procedure. Establishes or authorizes the Department to establish various fees for the implementation of the Act. Sets forth provisions concerning license renewal, restoration, and reciprocity, display of licenses, and continuing education requirements. Preempts home rule. Amends the Regulatory Sunset Act. Provides a repeal date of January 1, 2026 for the Illinois Registered Design Practitioner Act. Repeals the Interior Design

Title Act. Makes a conforming change in the Unified Code of Corrections. Effective immediately.

Synopsis As Introduced

Amends the Emergency Telephone Systems Act. Provides that if a public safety agency, public agency, qualified governmental entity, or Emergency Telephone System Board submits an affidavit to the Illinois Commerce Commission stating the amount of expenses for services that the responding agency has incurred because an employee or designee of a public safety agency was required to physically transfer 9-1-1 calls at the private branch exchange due to a failure by a system provider's trunk line, the Commission shall immediately reimburse the responding agency in the amount stated in the affidavit or \$1,000.00, whichever is less. Provides that if there are expenses requested greater than the amount the Commission immediately reimbursed, then the Commission shall provide full reimbursement to the responding agency within 90 days of receipt of an affidavit requesting the additional reimbursement. Effective immediately.

Synopsis As Introduced

Amends the Illinois Municipal Code. Provides that various documents that are submitted to the Comptroller must be filed within 180 days after the close of a fiscal year (removing the option to file as soon thereafter as various audits become available). Further changes audit due dates from 6 months to 180 days. Amends the Counties Code changing audit due dates from 6 months to 180 days. Effective immediately.
